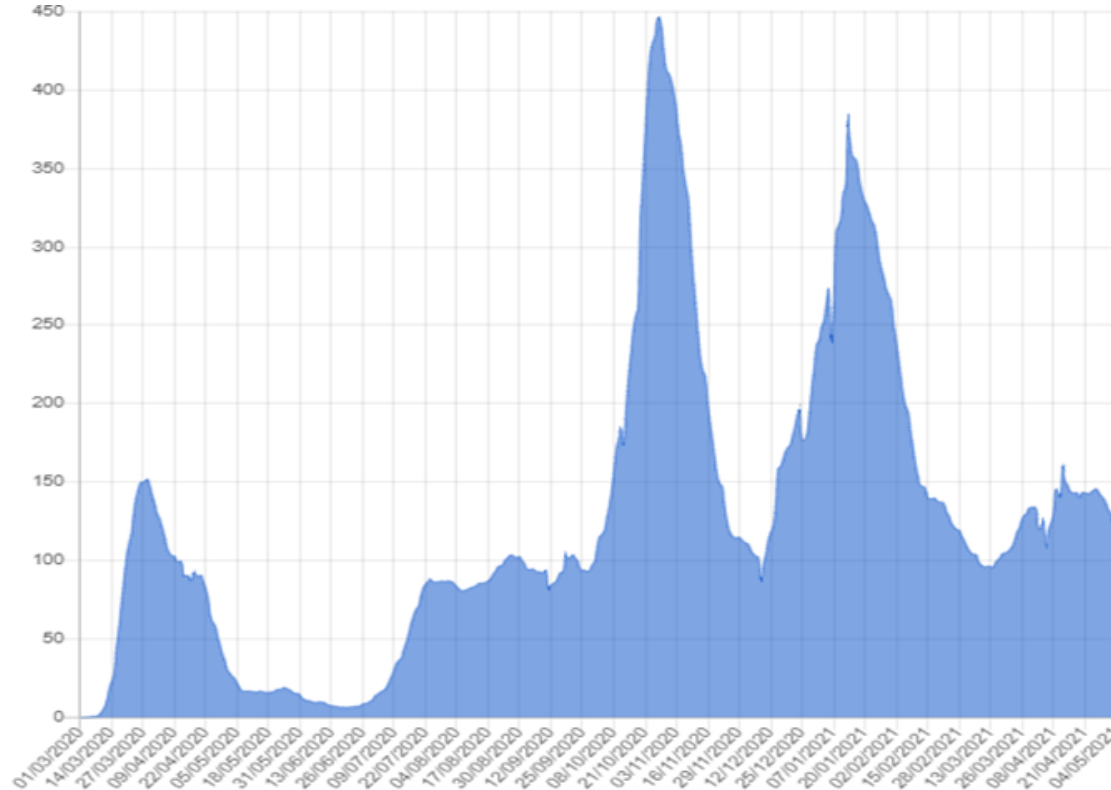

# Covid-19 data (12<sup>th</sup> May)

- ⊕ Total hospital beds occupation Covid cases Catalonia: **6.3 %**
- ⊕ Total ICU occupation Covid cases Catalonia : **32.6 %**
- ⊕ R infection rate: Baix Penedès county (IDIADA HQ) **0.67** / Garraf county (Sitges) **1.09**
- ⊕ 14-day case per 100,000: Baix Penedès county (IDIADA HQ) **140** / Garraf county (Sitges) **125**
- ⊕ Vaccination rate: 1<sup>st</sup> dosage **30%** adult population, 2<sup>nd</sup> dosage **13%** adult population

# Covid-19 audit carried out at IDIADA

IDIADA continues to **guarantee a safe environment** in order to protect all clients, visitors and staff working at our premises during the current health situation. Working at home is encouraged whenever possible for all IDIADA staff

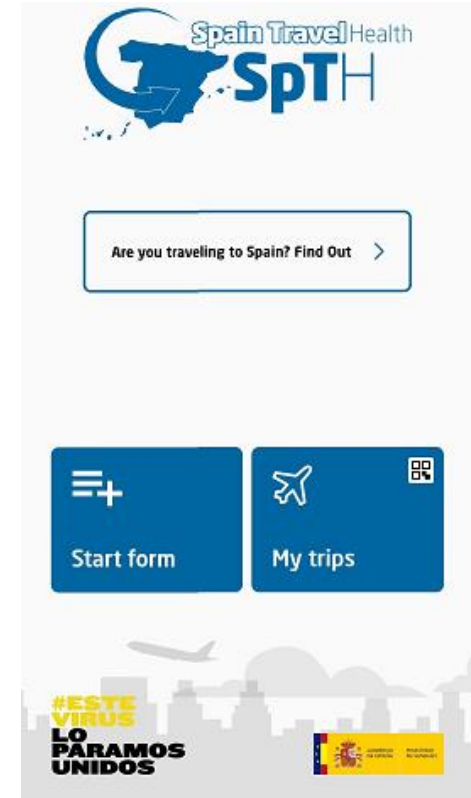

# Spain entry requirements

Entry requirements upon arrival at Spanish airports are as follows:

- ⊕ Spanish borders are open to EU/Schengen members
- ⊕ Persons from 'risk' countries, as determined by the European Centre for Disease Prevention & Control are required to provide evidence of a negative PCR, TNA or LAMP test taken within no more than 72 hours prior to arrival, in order to enter the country
- ⊕ Arrivals will need to present the FCS authorization form and QR code (official app available via [www.spth.gob.es](http://www.spth.gob.es)), undergo a temperature check and visual inspection by medical staff



# Spain entry requirements

- ⊕ Travelers from **non-EU/Schengen** countries should confirm with their consulate and airline regarding current restrictions to enter Spain and conditions for returning to country of origin



# Covid-19 containment measures (12th May)

- ⊕ The Catalanian government has put into place a system to vary the containment measures and restrictions applied in the region
- ⊕ Restaurants are permitted to operate at a limited capacity from **07:30h until 23:00h**
- ⊕ The wearing of facemasks is obligatory in all public areas and social gatherings are limited to a **maximum of 6 people**

# PCR/antigen testing service

- ⊕ To assist our clients, IDIADA provides a PCR and antigen testing service in order to [satisfy entry requirements for some countries](#)
- ⊕ PCR testing conducted by local health authorities' appointed laboratories is available for clients as required upon return to their home countries. **Test results will be provided within 24h**
- ⊕ To arrange an appointment for PCR testing, please request your IDIADA contact person 5 working days in advance
- ⊕ **IDIADA operates antigen (Ag) test services on its premises and is available to all employees, clients and visitors.** All IDIADA staff and visitors are encouraged to be tested on regular basis
- ⊕ IDIADA's medical center (ext. 43180) is open 24 hours a day to attend clients

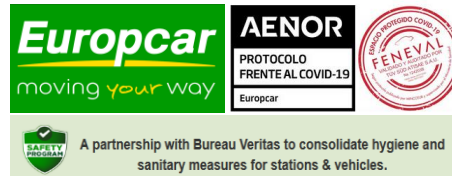

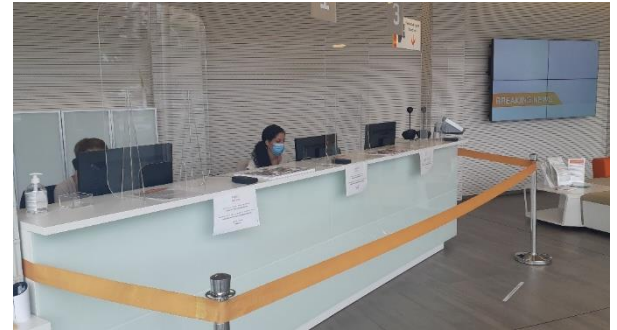
# Safeguarding visitors IDIADA

- ⊕ Antiseptic hydroalcoholic gel bottles are available at all entrances, receptions, toilets, meeting rooms and work areas
- ⊕ We monitor personnel, clients, suppliers and visitors' body temperature upon their arrival
- ⊕ A contactless entry system and a body thermometer have been enforced at access control
- ⊕ Employees and visitors who show symptoms (cough, fever, breathing difficulties) are **not allowed to enter**



# Safeguarding visitors to IDIADA

- ⊕ IDIADA's facilities and workshops are cleaned and sanitized using special products that offer protection against microorganisms for 24 hours after application
- ⊕ Specific disinfection protocols have been enforced for all equipment handed out to clients, such as radios or boosters
- ⊕ Workshop offices, meeting rooms and all common areas have been reorganized in order to ensure **social distancing** of at least 1.5 metres



# Safeguarding visitors to IDIADA

- ⊕ Workshop offices are sanitized using ozone generators before clients' check-in and on request during their stay
- ⊕ Ozone generator devices are also available for vehicle sanitizing



# Safeguarding visitors to IDIADA

- ⊕ The canteen service offers an assortment of pre-prepared hot and cold dishes
- ⊕ Dining areas both indoors and outdoors have restricted capacity to allow social distancing among users
- ⊕ Lunch service is available from 12:00h until 15:00h from Monday to Friday (except public holidays)
- ⊕ Meals can be taken in the canteen or to take-away
- ⊕ Private dining areas or delivery to the workshop can also be requested in advance





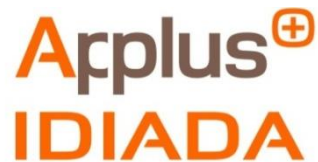
# Additional technical support and remote testing services

- ⊕ IDIADA's technicians, engineers, workshop mechanics and test drivers are on hand to assist with client's development programs, either remotely or by providing **direct support to your onsite testing team**
- ⊕ IDIADA's **live streaming** and **remote testing** services are a cost-effective solution to keep your testing activities running in times of travel restrictions due to Covid-19
- ⊕ A key factor of this service is to permit the client control of the whole testing process and be able to provide input during testing, including during the set up of instrumentation
- ⊕ IDIADA has put in place various communication and safe data-transfer tools to keep a constant communication flow between client and the IDIADA team
